

Strukton's sustainability goals – Carbon reduction goals 2026 - 2028

This document summarises Strukton Groep's¹ sustainable ambitions and goals.

1. By 2030 we have reduced our gross carbon emissions (scope 1 and 2) by 50% compared to 2021, related to the operating income
2. By 2040 we have our first year of carbon-neutral business operations
3. By 2050 we have our first year of business operations with zero CO2 emissions for scope 1, 2 and 3, and (if material) other influenceable emissions (OIE)

Our ambition to work climate-neutral in 2050 results in the following goals to reduce carbon emissions:

- We reduce our carbon emissions resulting from business travel² by 50% in 2030 compared to 2016, relative to the number of FTEs³
- We reduce the carbon emissions in the value chain for the production and commissioning of catenary supports of circular concrete by 55% in 2030 compared to 2023
- We reduce the carbon emissions in the life cycle of catenary wire by 56,4% in 2035 compared to 2024

The table on the next page shows our carbon emission goals per scope. The reduction goals for 2026 to 2028 are related to the previous year. We will set new, more ambitious goals when the goals are achieved before their respective end year as stated above.
